What Is A Will?

A will is a formal legal document that must be prepared, signed and witnessed in a particular form and following particular legal formalities. In essence, a will have the effect of disposing of the whole or part of the property of the willmaker to a beneficiary or beneficiaries with effect, broadly speaking, on the death of the willmaker.

What Do You Need Think About First?

The following table is designed to flag the information required by us as a starting point to prepare your will – although you need not *complete* it in detail, you should *consider* this information before we meet.
